2. The Tender Application Forms for the Re-allotment, details regarding the status of unit/vends and quota & reserve price of unit/vends can be obtained free of cost from the office of the Dy. Commissioner State Taxes & Excise, Kullu Distt. Kullu, Himachal Pradesh w.e.f **02/12/2023** onwards between 10:00 AM to 05:00 PM. 3. Every tender for the allotment of vend/unit shall be made in the prescribed format. A non-refundable bid/tender fee amounting to ₹1,00,000/- shall be deposited by every person who wishes to participate in the bid process or file tender. The bid/tender fee may be paid in cash or through Bank Draft at the time of entry into the Auction-cum-Tender hall.
4. Any applicant shall not be allowed to file more than one application for the same vend/unit.
5. The tenderer/bidder is required to submit following documents along with the tender:-
  - (i) A bank draft drawn in favour of the Dy. Commissioner State Taxes & Excise, Kullu, District Kullu, Himachal Pradesh issued by the scheduled Commercial Banks of India, Earnest Money with each tender which shall be equal to 2% of the reserve price fixed for the vend/unit. In case the bidder/tenderer is awarded the license, the earnest money shall be adjusted against the advance

License fee payable. In other cases it shall be returned to the tenderer/bidder as soon as the Re-allotment process is over.

- (ii) Declaration of solvency in the prescribed form (minimum 25 percent of the value of the Unit/vend). The licensee has to submit solvency certificate duly attested by the officer not below the rank of "Naib-Tehsildar"/"Solvency Certificate issued by Bank".
  - (iii) An affidavit in the prescribed form.
  - (iv) Two latest photographs along with proof of residence in the form of copies of the Voter Identity Card/Ration Card.
  - (v) A copy of valid PAN Card and Aadhar Card.
  - (vi) A prescribed tender form duly completed.
6. The tender application forms can be received and tender can also be filed on the day of opening of tenders as per the time allowed by the Allotment Committee.
7.
