**NOTIFICATION**

Whereas the draft amendments in Schedule-I appended to the Himachal Pradesh Toll Act, 1975 (Act No. 9 of 1975), were issued by the government vide Notification No. EXN-F(1)-3/2025 dated 06-03-2025 published in the Rajpatra (e-Gazette), Himachal Pradesh on 06-03-2025 in pursuance of the provisions of Section 3 of the aforesaid Act for inviting objections and suggestions from the person(s) likely to be affected thereby. But no objections/ suggestions have been received within stipulated period in this behalf.

Now, therefore in exercise of the powers conferred by Section 3 of the Himachal Pradesh Toll Act, 1975 (Act No. 9 of 1975), the Governor of Himachal Pradesh is pleased to substitute SCHEDULE-I appended to the aforesaid Act w.e.f. 01-04-2025 as under:-
